I hereby represent that my dog or dogs is or are in good health and has not or have not been ill with any known contagious disease or diseases whatsoever within the last thirty (30) days and that the health of my dog or my dogs is my responsibility. 5. I hereby represent that all required vaccinations (including without limitation, rabies, bordetella, revolution, distemper and parvovirus) are up-to-date and current. I will also continue to ensure that required vaccinations will be kept up-to-date and current for as long as my dog attend Ruff Spot Dog Daycare & Spa Inc. and immediately will notify staff at

(and its employees, directors, officers, owners, shareholders, representatives and agents) will not be held liable or responsible for any conduct, misconduct, or ailment that may develop with my dog or my dogs, including, but not limited to, sickness, disease, injury, running away and death. _____ Init.

It is hereby acknowledged that that should I fail to pick up my dog or my dogs before closing time a late fee will be charged to myself at the rate of \$20.00 per ½ hr. or part thereof, up to a maximum of \$80.00 to be paid in cash upon retrieval of my dog or my dogs from Ruff Spot _____ Init.
10. Daycare and Treadmill fees are non-refundable and non-transferable. _____ Init.
11. My dog or my dogs may be videotaped, photographed or recorded (howsoever created and whether digitally or otherwise) (hereinafter "the Product"). Ruff Spot Dog Daycare & Spa Inc. shall be the exclusive owner of the Product. _____ Init.
12. Ruff Spot Dog Daycare & Spa Inc., reserves the right to temporarily or permanently remove my dog or my dogs from its premises at any time. _____ Init.
13. Ruff Spot Dog Daycare & Spa Inc. may make rules and regulations respecting its operation of the premises, and may amend or vary such rules and regulations from time-to-time, and I agree to abide by and follow such rules and regulations. _____ Init.
